

Consent to the processing of personal data

In accordance with the Constitution of the Russian Federation, Federal Law of 27.07.2006 No. 152-FZ "On Personal Data", the Rules for the Processing of Personal Data posted on the website of LLC "TK "NEFTEPROMINVEST" at https://aeronn.ru/docs/Personal_Data_Policy.pdf (hereinafter referred to as the Rules for the Processing of PD).

I, the subject of personal data, hereinafter referred to as the User, by sending information through the feedback forms (hereinafter, each of them and all together - the Form, Forms) when completing the application procedure on the website <https://aeronn.ru> (hereinafter - the Site) for the purpose of receiving consultations on the products and services of the Operator, and further when using the Site, express full, unconditional and unequivocal Consent to the processing of my personal data (hereinafter - Consent) on the following terms:

1. The consent is issued to the Limited Liability Company "TK "NEFTEPROMINVEST (LLC "TK "NEFTEPROMINVEST" OGRN: 1075261010703 INN: 5261058533) located at: <https://aeronn.ru/> (hereinafter referred to as the Operator).
2. Consent is given for the processing of personal and other data specified by the User in the Forms by filling in the relevant text fields, namely the following information: last name, first name, patronymic; email address; telephone number.
3. Consent is given for the processing of personal data for the following purposes: placing orders for the Operator's products and services, receiving consultations on the Operator's products and services.
4. Consent is given for the processing of personal data, both with and without the use of automation tools; with transmission via the internal network of a legal entity; with transmission via the Internet. In the process of processing personal data, the Operator has the right to collect; record; systematize; accumulate; store; clarify (update, change); extract; transfer (provision, access); use; block; delete; destroy.

5. The User hereby confirms that:

5.1 Gives consent to the processing of his/her personal data specified in paragraph 2 of this consent, to the persons specified in paragraph 1 of this consent, and also confirms that the Operator has explained the consequences of failure to provide personal data, in cases where the provision of such data is mandatory in accordance with Federal Law No. 152-FZ of 27.07.2006 "On Personal Data".

5.2 Informed of the possibility of revoking consent on the basis of the provisions of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data" by personal appeal or by sending a written appeal (including in the form of an electronic document signed with a simple electronic signature or an enhanced qualified electronic signature) addressed to the persons specified in paragraph 1 of the Consent, including informed of the right to revoke Consent for the purpose of terminating the processing by the person specified in paragraph 1 of the Consent of both all personal data specified in paragraph 2 of the Consent and separately biometric personal data (if such are requested by the Operator and provided by the User).

5.3 I am informed that the persons specified in paragraph 1 of this Consent have the right to continue processing the User's personal data after receiving the revocation of the Consent, as well as after the expiration of the Consent, if there are grounds provided for in Part 2 of Article 9 of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data".

6. Consent comes into force from the moment it is sent and may be revoked by the User by sending a written statement in any form to the Operator by e-mail at info@aero-nn.ru or by any other means that allows the fact of its receipt by the addressee to be clearly determined.

7. The consent shall cease to be effective from the date specified in the User's application for revocation of the Consent to the processing of Personal Data, but not earlier than the date following the date of actual receipt by the Operator of the revocation of the Consent.

8. The date and time of formation, confirmation and sending of the Consent shall be considered the moment of marking the corresponding field (or clicking the corresponding button) in the Form and/or clicking the Form send button on any page of the Site.

9. Guided by Part 4 of Article 9 of the Federal Law of 27.07.2006 No. 152-FZ "On Personal Data", I send my personal data through a personal mobile device or personal computer by filling in the appropriate fields of such form when submitting an application for consultation on the services of creating and using databases and information resources on the Site.

10. In the event that the subject of personal data revokes consent to the processing of personal data, "TK "NEFTEPROMINVEST" LLC has the right to continue processing personal data without the consent of the subject of personal data if this is provided for by the legislation of the Russian Federation.
